Deposit: Deposit to hold a puppy, in planning, in utero or once born is \$400. The amount is non-refundable unless the following arises:

- 1) The dam does not produce a litter and the buyer does not want to wait until the next available litter.
- 2) The requested gender of puppy is not available and the buyer does not want to wait until the next litter.
- 3) During the health exam at the breeder's veterinarian, a problem is reported and the buyer no longer wants the puppy, in which case the buyer can apply their deposit toward a different puppy, if available. If not available, a cash refund or credit toward the next litter will be offered.
- 4) Gallant Cotons reserves the right to refund any amount, any time, at their discretion.

Under these circumstances, the buyer will receive their deposit back within a reasonable time following the announcement to buyer.

No deposit will be refunded due to "change of heart", medical issues, moving homes, new baby, divorce/marriage, etc. You can choose to refuse delivery of the puppy (up until the puppy leaves Gallant Farm for its new home) and instead apply the deposit later toward another puppy from a future litter.

Microchip: Gallant Farm has provided your new puppy with a microchip for its future safety. Gallant Cotons will register the puppy's information in a national database, free of charge, with the information you provide to us. If your information (address/phone etc) changes, you will be responsible for having it updated as soon as possible for the safety of your dog. Gallant Cotons will remain as a "secondary rescue contact" in the National Database, for the lifetime of the dog.

Registration of your puppy: At the time of pickup of your new puppy, you may view parental registrations. All puppies are sold on a spay/neuter contract. The buyer agrees to have the puppy spayed or neutered within 12 months of age. Any available registrations (AKC, UKC, etc) will be sent if requested when the puppy is spayed/neutered, and documentation of proof is sent to Gallant Farm.

Your new Coton de Tulear puppy purchased from Gallant Farm comes with a "healthy puppy" guarantee!

Health Inspection by Veterinarian:

Your Gallant Coton will be guaranteed to be in good health as described below when he or she is delivered to you. The puppy will be fully vet-checked, he or she will have exams for eyes, ears, bite/teeth, nose, skin, joints, feet, heart, lungs, abdomen and a check for external parasites. If the exams don't have perfect results, you will be notified of any conditions before finalizing the sale by leaving the property with the puppy. Your puppy will be properly vaccinated and will have been on a deworming program beginning at 2 weeks of age. We have cared for this puppy like it was one of our own (because he/she is!). You will also receive record of vaccinations and de-wormings that you may present to your veterinarian.

Conditions of guarantee:

Buyer must provide adequate care for the dog, feed a quality food and make every attempt to keep the dog's weight at a normal, healthy level. The buyer must provide necessary vet care & preventative care, including keeping the teeth clean (infections in the mouth can lead to Mitral Valve Disease). We ask that you do your best to keep your Coton de Tulear at a weight reasonable for their stature to extend their life.

The buyer will be responsible for all daily health care for their Gallant Coton, including immunizations, examinations recommended after purchase, as well as providing necessary medications and follow-up treatment from veterinarian visits. The buyer is responsible for any and all expenses accumulated from the day they take possession of their puppy. Gallant Farm can't be responsible for any contagious illnesses after 48 hours because they could have been contracted after the dog has left our facility.

Unable to be covered by seller, are common puppy ailments such as: parasites, undescended testicles, under/overbites, dental issues (except cleft palate), allergies, ear mites, coccidia, giardia, hypoglycemia and respiratory infection. Fair coverage to be determined by Gallant Farms. No claim will ever exceed the purchase price of the puppy.

*** The buyer must spay or neuter their Gallant Coton by 12 months of age unless other arrangements are agreed to in writing. You are purchasing this puppy with NO BREEDING RIGHTS unless you have a separate breeding rights contract signed by me AND notarized. We take this very seriously. You may be responsible for financial damages by Gallant Cotons for every litter produced if your Gallant Coton is found to have produced a litter(s) of puppies. ***

If your Gallant Coton is discovered to have a genetic disorder before the age of 12 months (heart, lungs, liver, cancer, hip dysplasia, eyes) the buyer will provide the seller with a letter from the attending veterinarian (DVM) on office letterhead which includes documentation of diagnosis, diagnostic test results, breed of dog, birthdate, microchip number, and signature of verification. This genetic disorder must be verified by a licensed veterinarian and documentation presented during the puppy's first year.

Should your veterinarian determine the puppy has a covered genetic condition, the buyer has the option to immediately return the puppy to Gallant Farm, at the buyer's expense. Within a reasonable time, we will issue a refund check for the purchase price of the puppy. Flight expense, shipping prep fees, veterinarian fees, etc will not be considered for a refund.

Should you choose to keep the puppy, and treat any medical illness found, the buyer agrees not to hold the seller financially liable for any expenses.

In the very sad event of the pet's death within the first 7 days, if an autopsy report states specifically that the death was the result of a genetic illness or an illness which was contracted while in the care of Gallant Farm, the price of the puppy and the autopsy fee will be refunded. Within a reasonable time of receipt of the autopsy report, we will issue a refund check in the amount of the purchase price of the puppy, and the autopsy fee (not to exceed \$200).

Please remember that flight expense, shipping prep fees, vet fees, etc. will not be included in this refund. Only the purchase price of the puppy, and the actual autopsy fee can be refunded. Of course, accidental death or lack of proper care would not be covered in the guarantee and no reimbursement would be made.

While we do our best to get you the puppy you want, Gallant Farms does not guarantee size, color, trainability, or temperament. If at any time during your puppy's life you decide you can no longer keep your puppy, we ask that you return the dog to us, if feasible. We can help in re-homing when necessary. No monetary compensation can be given in re-homing situations, but finding a good home is always our top priority, or we will keep the dog ourselves.

If, for any reason any litigation of this transaction occurs, they shall be held within the County of Chisago, in the State of Minnesota. If any part of this guarantee should be in violation of a law, that section of the contract shall become null and void.

This guarantee is non-transferable should the buyer choose to re-home their Gallant Coton.

This guarantee is valid for one year from the puppy's date of birth. Buyer takes 100% responsibility for future costs and care after the puppy turns one year of age.

Buyer: By purchasing a puppy from Gallant Cotons, I am agreeing to the terms of this contract.

I agree to spay/neuter my puppy before the age of 12 months at which time I can present proof of spay/neuter to Gallant Cotons to obtain AKC/UKC registration papers.

I agree not to breed my Gallant Coton de Tulear under any circumstances unless I, the buyer(s), have a seperate breeding authorization signed and notarized by Tracy Welsch and myself, the buyer.
